#### FG040 RESERVES POLICY

- i.After a discussion it was resolved to recommend the Minimum Reserves Policy as presented for adoption at the next Full Council meeting
- ii.To review first draft of financial risks facing the Parish Council as per 2.2.5 of Draft Minimum Reserves Policy. This was deferred to a future meeting to allow more time to properly assess the risks.
- iii.To consider the addition to the budget for reserves to be recommended to Full Council Projected. It was agreed to discuss this item with the budget review item FG042.

#### FG041 VILLAGE HALL MEETING

The recommendation to full Council is that it's not able to add any additional funds to the precept for the Village Hall in this budget due to depleted reserves.

#### FG042 BUDGET 2025/2026

The projected Year End accounts and Budget recommendations were reviewed. Projected general reserves figure at the year-end is £4700. This is less than the figure required.

It was resolved to recommend to full Council that £12,700 is added to the budget for general reserves to bring them in line with the minimum amount required.

After a discussion it was resolved the precept request of  $\pounds$ 82,300 for 25/26 would be recommended to full Council.
